1. Interested persons/parties may submit their bid, in a PRESCRIBED FORM and PRESCRIBED COVER (ENVELOPE) latest by 12:00 Noon of 13/08/2019. The duly sealed cover should be dropped in the Tender Box kept at Personal Branch of Secretary, AMC at 3<sup>rd</sup> Floor, AMC Office, Thuampui, Aizawl. The outer cover of the envelope should be super-scribed as:

2. Tender Form shall be signed in ink/ball point pen by tenderer or the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
3. Quotation should be free from correction, overwriting, using correcting fluids. If the case arises, overwriting or correction should be initialed by the bidder.
4. The sale of vehicle shall be strictly on "as is where is basis" and no guarantee or certificate of its worthiness or quality will be given by the AMC. The conditions of the vehicles can be inspected physically.
5. EMD amount is payable by means of cash wherein Receipt/Token will be issued. EMD is fixed at **Rs 2,000** /- for the vehicle. In case the offer is withdrawn by any bidder, the EMD deposited shall be forfeited.
6. AMC is not bound to accept the highest bid. The successful bidder will have to deposit the total amount of his/her bid within a week from selection of successful bidder.

7. EMD of unsuccessful bidders shall be returned within 14 days of the award of the successful bidders upon submission of application for release of the same in writing addressed to The Secretary, AMC.
8. The successful bidder shall be required to submit documentary evidence in support of residential status (Ration Card/Voters Identity Card/Aadhaar Card/PAN Card in case of individual and registration Certificate in case of firms etc.).
9. The responsibility of Aizawl Municipal Corporation with regard to watch of stationed sold vehicle ceases immediately after the successful auction i.e. after payment of the bid amount to AMC. The successful bidder has to take delivery of the auctioned vehicle within a week at their own expenses from the date of payment of their bid amount. No assistance/transportation will be provided by AMC.
10. Along with the tendered amount the GST if any, fixed by the Central Government or Government of Mizoram in respect of each auctioned vehicle may be collected as extra.
11. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost. This office will not be responsible for any lapse on his part in this regard.
12. The Competent Authority of AMC reserves the right to withdraw any item or lot and to reject any/all of the quotation fully or partially or cancel the sales of vehicle at any stage without assigning any reason thereof.
13. Any dispute over the quality and value of the vehicle put to auction cannot be entertained after auction.
14. The Aizawl Municipal Corporation reserves the right to accept or reject or alter any bid without assigning any reason thereof.
15. In case of any dispute, with relate to auction of the vehicle, the decision of the Aizawl Municipal Corporation will be final and binding.
