## TERMS AND CONDITIONS

- 1) Quotation Form may be obtained from AMC Office Cash Counter at 3<sup>rd</sup> Floor of AMC Office building on any working days on payment of Rs. 100/- per form.
- 2) Earnest Money Deposit (EMD) is fixed at Rs 3,000 /- for each vehicle which is payable by means of cash.
- 3) The quotation should be submitted separately for each condemned vehicle along with a separate EMD.
- 4) Tender Form shall be signed in ink/ball point pen by tenderer or the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
- 5) The prospective purchasers are advised to inspect the vehicle(s) at AMC Office Basement and Ch. Saprawnga Truck Terminal (CSTT), Rangvamual and quote the maximum amount/outright price they are prepared to pay for the same on 'as is where is' basis.
- 6) The quotation should be submitted in the prescribed form and must be accompanied by the requisite Earnest Money Deposit.
- 7) The quotation in the prescribed form duly completed in all respect should be submitted in sealed envelope addressed to the Municipal Commissioner, Aizawl Municipal Corporation, Thuampui, Aizawl, Mizoram - 796017 which must be superscribed as "**Quotation for purchase of condemned motor vehicle**" indicating the registration number and type of the vehicle quoted for.
- 8) The quotationer should quote his/her bid amount both in figures and in words. Any correction/over-writing/cutting on tender form must be initialed by him/her with date without which the quotation will be liable to rejection.
- 9) The successful quotationer will have to deposit the total amount of his/her bid within 7 days from the date of issuance of acceptance of his/her tender, failing which his quotation will be treated as cancelled, and the Municipal Commissioner, AMC may



dispose the vehicle to the 2<sup>nd</sup> highest quotationer at his bid amount with forfeiture of earnest money of declining quotationer.

- 10) The successful quotationer shall have to remove the vehicle after making full payment of the settled amount and remove the vehicle within 10 days after issuance of release order. No assistance/transportation will be provided by AMC.
- 11) EMD of unsuccessful quotationers shall be returned within a month of the award of the successful quotationer upon submission of application for release of the same in writing addressed to The Municipal Commissioner, AMC.
- 12) The number of valid quotationers in each case should be more than 1 (one) for comparison. Otherwise, the undersigned will have the right to dispose the vehicle as it deem fit without further re-quotationing.
- 13) The undersigned reserves the right to reject all or any quotation without assigning any reason. Quotation which is not accompanied by requisite Earnest Money Deposit shall be summarily rejected.
- 14) If the highest/successful quotationer withdraws his tender after opening of the quotation, his/her earnest money will be forfeited and will be credited into AMC account, and the condemned vehicle will be sold to the next suitable quotationer at the risk of the defaulting quotationer.
- 15) The successful quotationer will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her name at his/her own cost. This Office will not be responsible for any lapse on his part in this regard.
- 16) Any dispute over the documents, quality and value of the vehicle put to auction cannot be entertained after auction.
